

Organic Christians Buying Club makes the Buying Club available exclusively to Members. Membership is subject to any and all rules adopted by Buying Club. Buying Club rules may be amended from time to time without notice to or consent of Member. Memberships may be terminated at Buying Club discretion. Membership is annual ongoing.

Membership. Membership Account Set up and Membership fee is paid by applicants at the time they submit application. If the application is rejected, then the Membership is returned in full. Upon acceptance, Members are provided with identification and log-in information and are permitted to access online shopping and make purchases at Organic Christians Buying Club.

Shopping. When shopping online at Buying Club, purchases must be paid for using Debit and credit cards, paypal, or cash when arrangements have been made. Buying Club does not accept paper checks, American Express, Discover, or any other method of payment. Title to all merchandise passes to the member at the time of payment. At times there will be additional charges for example if your purchase Two New York Strips and the actual weight ends up being 0.25 lbs more the buyer will be told when the order is pulled by the farmer and charged accordingly to make up the difference. Also, we may have to wait another week (or amount of time it takes) on a split order in the event the minimum is not met. For example: 25 lbs of feed for a trip to be made to Asheville, \$250 minimum with wholesale distributor, or 50lbs of Organic Wheat Flour picked up at Lindley Mills (in the future plans)

Payments Refused, Dishonored, and Returned NSF. Buying Club will charge a fee of 25.00 for any payment that is refused, dishonored, or returned NSF. This fee is charged each time the payment is refused, dishonored or returned.

any kind. Only your name will be given to the farmers for coordinating and pulling each order. If you are contacted directly by a farmer without prior notice from Organic Christians please let us know.

If at any time transactions are done dishonest or a member is found to be untrustworthy within our organization they will be asked to terminate their membership. We will not tolerate any unkindness, gossip, discouragement within our community meetings or gatherings!
